

# JAMES MACEY PHOTOGRAPHY



## CONTRACT FOR WEDDING PHOTOGRAPHY

It is mutually agreed that the following terms of agreement form an integral part of this contract and that no variation or modification of this contract shall be effective unless accepted by James Macey Photography in writing.

**BOOKING FEE** - A Booking Fee of 25% is required when you sign the Booking Form and this will secure your date. Please make cheques payable to James Macey. This deposit is fully refundable 3 months prior to the wedding date.

**PAYMENT** - Payment for the balance of the Package is to be made in two stages.  
25% to be paid when ordering the album (not more than 6 weeks after the wedding),  
50% to be paid upon delivery.  
Payment for mini books, parent's albums and reprints are made when you order them. Any bank charges due to returned cheques will be charged directly to you.

**WEATHER** - Weather permitting, all the photographs will be taken as agreed. In the event of rain, wind, or any form of adverse weather, the photographer will make the necessary changes in the photography session and will not be responsible for any disappointment caused by the weather. However, the photographer with the co-operation of the client will do his best to produce coverage of the wedding within the time allocated to him.

**PHOTOCHROMATIC ANOMALIES** - Owing to reflectance caused by a combination of certain dyes and materials, especially man made fibres, it is sometimes impossible to record the exact colour of a garment as seen by the human eye. The photographs will provide a pleasing colour balance based on the flesh tones of the subjects but cannot guarantee exact colour match. The printer will use their skills to produce pleasing prints, and no refunds can be considered.

**REQUESTED SHOTS & SHOOTING SCHEDULE** - Four weeks prior to the wedding the client is to complete the Pre-Wedding Form and return along with any maps/directions. The photographer will produce a photographic shooting schedule along with suggested shot list based on this information. This will be sent by email to the client for sign off one week prior to the wedding. The photographer will honour all shots requested and agreed in advance on the shooting schedule provided the following factors are met: weather and allocated time permitting, availability and co-operation of person(s) concerned.

**ATTENDANCE & COVERAGE** - Attendance is for four to five hours to include the bride's preparation, ceremony, drinks reception and entering the wedding breakfast. Additional coverage is available at £50 per hour or part thereof. Extra coverage can be agreed prior to the wedding. In the event that the wedding runs over the agreed five hours attendance the photographer shall notify the client and jointly decide whether additional coverage is required. The photographer cannot be held responsible for the lack of coverage caused by the bride, the groom or wedding party being late or by The Church, Register Office or Licensed place of wedding restrictions regarding photography. Unless agreed in writing the photographer does not guarantee any specific picture nor incorporate any specific background, location or group arrangement. In the unlikely event that James Macey is unavailable to attend the wedding all efforts will be made to provide a second photographer through the SWPP, although this cannot be guaranteed.

**VIEWING & PRODUCTION** - A web site or proof book will be sent to the client approx three weeks after the wedding.

Album and Artbook picture choices (if clients are selecting them) must be made 30 days from receipt. Once pictures have been selected for an album or Artbook a planner will be provided for client approval prior to production. Ten alternative picture changes to the planner are allowed free of charge, after that @ £15 per change. Album and Artbook planners must be signed off with any changes within 7 days of receiving them.

**COPYRIGHT AND USAGE** - All copyrights, as well as originals, remain the sole property of James Macey Photography unless otherwise specified before the event. The Photographer will retain originals for not less than one year after the Date of Fulfilment. Only those prints ordered and paid through the Photographer become property of the Clients. No scanning, reproducing, or reprinting is allowed without the expressed written permission of the Photographer.

**MODEL RELEASE** - The signing of this agreement by the Clients constitutes a commercial model release by the Clients to the Photographer. The Photographer will have the right to make reproductions for portfolio samples, self-promotion, commercial use and professional competition without further release. James Macey shall be the sole (stills) photographer at the venues specified. The due performance of this contract is subject to alteration or cancellation by James Macey Photography owing to any cause beyond their control. Every care is taken in photographing and processing using professional materials. In the unlikely event of total photographic failure the Photographer's liability shall be limited to a full refund of all money paid. Your statutory rights are not affected and James Macey Photography has full Public Liability and Professional Indemnity Insurance.

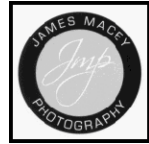
